Overview

The purpose of collecting Emergency Department data in NSW is to monitor patient presentations to, and the activity undertaken in, the Emergency Departments (EDs) of public hospitals and in scope contracted private hospitals in NSW.

Each record in the Emergency Department Data Collection (EDDC) represents a presentation to an emergency department.

An Emergency Presentation is where a person presents to the Emergency Department for emergency care and treatment. This includes patients that are transferred from another unit or ward within the facility or another facility's Emergency Department for treatment within the ED. Presentations to an Emergency Department include, but are not limited to, patients who:

- Register to be seen for an ED service but did not wait for the service to be delivered
- Are triaged and advised to seek alternate services, and then depart the ED
- Are dead on arrival if an ED clinician certifies the death
- Are provided with clinical assessment and advice via telehealth. Such services must be identified as being provided via telehealth

A patient treated in the ED who is subsequently admitted to the hospital will require the reporting of an ED presentation to the EDDC and an admitted patient record reported to the Admitted Patient Data Collection.

Scope and coverage

The following health organisations must report all emergency department service events they provide to the collection:

• NSW Public Hospitals and in-scope contracted private hospitals with an Emergency Service Role Delineation of Level 1 or above.

Emergency Service Role Delineations for NSW Hospitals are published in the <u>Role Delineation</u> <u>Levels of Emergency Medicine for NSW Hospitals</u>.

The scope, coverage and content specifications for the NSW Emergency Department Data Collection has varied over time

Historical coverage

- The NSW EDDC commenced in 1994. It was only organised into a formal data collection from July 1996.
- Personal identifiers were included in the data collection from 1 January 2005 onwards.
- The number of hospitals participating in the EDDC has increased over time from approximately 52 in 1996-97 to 184 in 2016-17. The number of hospitals participating has been lower in rural Local Health Districts.
- Historically, the larger EDs participated in the EDDC so a substantial proportion of the NSW
 population was covered, however this varies over time. To determine the proportion of total NSW
 ED visits captured by the NSW EDDC, use the number of ED presentations reported in the NSW
 Health Annual Report as a denominator, as the reports provide an independent source of
 information collected on all hospitals.

Diagnosis information in Emergency Department data

The NSW Admitted Patient Data Collection has diagnoses coded by trained clinical information managers who choose diagnoses from the International Statistical Classification of Diseases and Related Health Problems, Tenth Revision, Australian Modification (ICD-10-AM). The EDDC, on the other hand, has diagnoses recorded by medical, nursing, or clerical personnel at the point of care.

These personnel are not trained in clinical coding. Diagnoses are searched from drop-down lists in the ED Information System / eMR. The description the clinician sees is mapped to a diagnosis or activity code.

Other points to note are:

- There are several different electronic medical record (eMR) systems used in NSW Emergency
 Departments (EDs). Different eMR systems use different medical classification systems to
 record the diagnosis, including ICD-9-CM (Clinical Modification), ICD-10-AM (Australian
 Modification), or <u>SNOMED CT</u>. If you intend to analyse ED diagnoses, you will need to identify the
 codes from each of these classification systems that relate to the disease or symptom grouping
 you will be studying.
- Variation in eMR systems and management practices in EDs may lead to variation in diagnosis coding practices. Some disease codes are not available in some eMR systems but are in others.
- A small number of hospitals have limited diagnosis code completion over some periods of time.
- Digital Health Australia (DHA) maintain a SNOMED-CT reference set Emergency Department settings in Australia. This is mapped to the full ICD-10-AM list and the Independent Health and Aged Care Pricing Authority (IHACPA) Emergency Care ICD-10-AM Principal Diagnosis Short List. Researchers can obtain these mappings from IHACPA.
- You should carefully consider which EDs to include in the analysis based on how long the ED has participated in the EDDC, the type of diagnosis classification system used, and completeness.
- Symptoms can be, and often are, selected as diagnoses.
- Diagnoses can be very specific or very broad. For example, someone with the same symptoms might be assigned a diagnosis of "influenza" or "viral infection".
- External causes are rarely captured in ED diagnosis codes.

Interpreting variation in Emergency Department activity

The main source of primary care in Australia is in general practice (GP) in the community. ED activity may be very sensitive to the local availability of GP services. Local GP services may experience variability in GP service availability, opening hours and bulk billing practices.

The availability of <u>Urgent Care Services</u> and <u>Medicare Urgent Care Clinics</u> will also impact local ED activity.

Access to information on Aboriginal and Torres Strait Islander peoples

An application to the Aboriginal Health and Medical Research Council (AH&MRC) ethics committee should be made for research projects for which one or more of the following apply:

- The experience of Aboriginal people is an explicit focus of all or part of the research
- Data collection is explicitly directed at Aboriginal peoples
- Aboriginal peoples, as a group, are to be examined in the results
- The information has an impact on one or more Aboriginal communities
- Aboriginal health funds are a source of funding

Research that is not specifically directed at Aboriginal people or communities, such as for the total population or a sub-population (e.g., rural NSW, people over 50 years old) can still potentially impact on Aboriginal people.

However, an application for such research need only be made to the Committee if any one of the following applies:

Any of the five factors listed above are present: or

- Aboriginal people are known, or are likely, to be significantly over-represented in the group being studied (e.g., compared to the proportion of Aboriginal people in the NSW population for the study period); or
- The Aboriginal experience of the medical condition being studied is known, or is likely, to be different from the overall population; or
- There are Aboriginal people who use the services being studied in distinctive ways, or who have distinctive barriers that limit their access to the services; or
- It is proposed to separately identify data relating to Aboriginal people in the results.

The AH&MRC ethics committee have some specific requirements, including evidence of community engagement in the research. Data stream details

Emergency Department Data Stream

EDWARD Format

On 1 July 2023 NSW Health launched a new centralised data warehouse known as EDWARD: a contemporary system to ensure our information is high quality, integrated, accessible and utilised.

For record linkage projects:

- NSW Emergency Department data is available in EDWARD format for service events from 1 July 2023 onwards.
- Northern Beaches Hospital Emergency Department data is available in EDWARD format from 30 October 2018.
- Records from Albury Base Hospital Emergency Department are not available in EDWARD format.

Data structure

For record linkage projects, EDWARD format data is available in the following structures:

- Service event information and client characteristics
- Service event diagnosis information.

The Service Event Combined Business Key Surrogate Key should be used to join Diagnosis information to the Service event and client characteristics.

In EDWARD, the full client characteristics and history are reported by a dedicated data stream for all NSW Health clients – the Client Characteristics Data Stream.

For Emergency Department service events, unless otherwise specified, client characteristics represent the client details at the start of the service event.

Organisation Service Provider Information for service events is recorded and made available for linkage projects as a 7 Digit Identifier based on the relevant entry in the NSW Health Establishment Registration Online (HERO) application (PD2024_042).

Within the Emergency Department Data Stream, the Organisation Service Provider OSP ID reported as Creating / Responsible for the Service event will generally be the OSP ID for the Emergency Department "Service Unit" within the Health Organisation (Hospital).

- The Health Organisation OSP ID is also available and will generally correspond to what is recorded as the Organisation Service Provider OSP ID in the Admitted Patient Data Stream.
- The Health Organisation OSP ID for an ED service event will generally correspond to the Organisation represented by HIE Facility Identifier in the legacy data

More than one ED Diagnosis Code per service event is available where reported in EDWARD. See Emergency Department Data EDWARD Format variable list for variable list.

Legacy / Historical data availability

Emergency Department data is available for record linkage projects for the period 1 January 2005 – 30 June 2023 in a legacy data format.

Legacy Emergency Department Data is available in the following structures

- Emergency Department Visit information and client characteristics
- Emergency Department Visit Diagnosis information.

Facilities are recorded in the Emergency Department Data using a 4-Digit HIE facility identifier.
