## Overview

The NSW Admitted Patient (Private Sector) Data includes details of the services provided to patients who are formally admitted to a NSW Health licensed private hospital or day procedure centre. Details about the admitted patient separations are recorded in patient administration systems. The details captured include:

- patient characteristics (demographics)
- hospital stay administrative details
- professionally coded clinical information pertaining to interventions the patient received, diagnoses, external cause, activity when injured, place of occurrence and morphology associated with primary sites of cancer.

## Scope and coverage

The following health organisations must report all admitted patient activity they provide to the collection:

- NSW Health licensed private hospitals and day procedure centres.

NSW Admitted Patient (Private Sector) Data supply requirements and content specifications have varied over time.

---

## Clinical coding: Diagnosis and interventions / procedures

- Diagnosis information is classified according to the International Statistical Classification of Diseases and Related Health Problems, Tenth Revision, Australian Modification (ICD-10-AM)
- Procedures and interventions are classified according to the Australian Classification of Health Interventions (ACHI).
- The Australian Coding Standards (ACS) specifies coding standards that provide guidelines to assist users of the classifications in obtaining consistency in clinical coding nationally. Public and private hospitals in Australia use ICD-10-AM/ACHI/ACS to classify episodes of admitted patient care. These classifications are generally updated every two years to ensure they are fit for purpose and remain clinically current.
- Descriptions of the ICD-10-AM/ACHI/ACS codes are not provided. You can access descriptions from the [Independent Health and Aged Care Pricing Authority](#).

## Changes to NSW admissions policy

From 15 June 2017, emergency department (ED)-only episodes of care were no longer included in admitted patient data. Consideration should be given to excluding ED-only episodes of care from analyses to provide ensure with historical data. See the [HealthStats NSW Statistical methods paper](#) for more detail.

## Considerations when requesting NSW Admitted Patient (Private Sector) Data

### Limited patient names will affect linkage

Patient names are not generally available for admissions to private hospitals prior to 1 July 2015. While the CHeReL attempts to link these records based on other demographic details, the linkage is likely to be less accurate. Caution must be exercised in interpreting results where NSW Admitted Patient (Private Sector) Data are involved.

## Requesting facility identifiers and names

Facility identifiers will be provided in masked form for NSW Admitted Patient (Private Sector) Data records unless

- there is strong and clear justification for needing to identify individual private health hospitals
  - the Data Custodian explicitly supports the request.
- 

## Access to information on Aboriginal and Torres Strait Islander peoples

An application to the Aboriginal Health and Medical Research Council (AH&MRC) ethics committee should be made for research projects for which one or more of the following apply:

- The experience of Aboriginal people is an explicit focus of all or part of the research
- Data collection is explicitly directed at Aboriginal peoples
- Aboriginal peoples, as a group, are to be examined in the results
- The information has an impact on one or more Aboriginal communities
- Aboriginal health funds are a source of funding

Research that is not specifically directed at Aboriginal people or communities, such as for the total population or a sub-population (e.g., rural NSW, people over 50 years old) can still potentially impact on Aboriginal people.

However, an application for such research need only be made to the Committee if any one of the following applies:

- Any of the five factors listed above are present: or
- Aboriginal people are known, or are likely, to be significantly over-represented in the group being studied (e.g., compared to the proportion of Aboriginal people in the NSW population for the study period); or
- The Aboriginal experience of the medical condition being studied is known, or is likely, to be different from the overall population; or
- There are Aboriginal people who use the services being studied in distinctive ways, or who have distinctive barriers that limit their access to the services; or
- It is proposed to separately identify data relating to Aboriginal people in the results.

The AH&MRC ethics committee have some specific requirements, including evidence of community engagement in the research. ## PHISCO Format

From 1 July 2015, all NSW Health licenced private hospitals and day procedure centres have reported using in the Admitted Patient (Private Sector) Data extract format (PHISCO Format).

In the period 1 July 2012 – 30 June 2015, some NSW Admitted Patient (Private Sector) Data was submitted in PHISCO format.

### Data structure

The PHISCO data is available in a flattened data format with a single row for each hospital stay.

Facilities are recorded in PHISCO data using the 4-Digit HIE facility identifier.

## Legacy / Historical data availability

NSW Admitted Patient (Private Sector) Data for record linkage projects is available for the period 1 July 2001 to 30 June 2015 in a legacy format.

Facilities are recorded in Legacy Private Hospital data using the 4-Digit HIE facility identifier.

- Hospital stay administrative information and client characteristics
